#### **Elkan Abrahamson**

one of the architects of Hillsborough Law. specialise in major public Inquiries and Inquests and in challenging decisions made by authorities like City Councils and Government. I'm proud to have represented 20 families during the <a href="Hillsborough">Hillsborough</a> inquests and continue to support them in the aftermath, I also act for families involved in the Birmingham Pub Bombings Inquest and The Manchester Arena Bombings Inquest. I provided pro bono consultancy to one of the family firms involved in the Grenfell Inquiry.

#### **CLAIR WALTON**

She set up POSITIVE WOMEN with 'Frankie' in 2017 to campaign for justice and to ensure HIV infected wives/partners are not marginalised, edited or erased from the Contaminated Blood Scandal and the history of the haemophilia community. She campaigns so their experience and ongoing needs as infected with HIV are recognised and understood.
